# Highlights of Project Activities



5 Sub-district Level VCF Net- Livelihood Security & Environwork Committee Formations at Five Sub-district Clusters/Sagala **Under Rangamati Hill District**

Under the 'Promoting a Network of Village Common Forests and Building Capacity of the Network Members in Chittagong Hill Tracts' in brief- VCF Net Project Taungya project team members successfully completes formation programmes of Sub-district level VCF Network Committee formation form 7th October to 13<sup>th</sup> October 2017. To facilitate the programmee Rangamati District was divided into 5 sub-districts. They are-

- 1. Rangamati Sub-district Cluster/ Sagala
- 2. Jurosori Sub-district Cluster/ Sagala
- 3. Longodu Sub-district Cluster/ Sagala
- 4. Barkal Sub-district Cluster/ Sagala
- 5. Thega-Horinga Sub-district Cluster/ Sagala

It is quite rational that geographical context, quantity of community conserved forests that is VCFs, district size that is number of upazila, communication scenario etc. of Rangamati Hill District is unlike Khagrasori and Bandarban. So, Rangamati District level Network Committee realizes the necessity of Sub- district Network Committees to manage administrative, coordination, monitoring and troubleshooting issues properly. The committee formation processes were facilitated to ensure participatory or democratic participation of the VCFs where maximum VCFs of respective sub-district representatives exercised their rights to vote for EC member selection. Five election boards were formed at five sub-district clusters to elect EC members of the respective sub-districts. The election boards facilitate the election process under their Oath taking of the Jurosori committee respective Chiefs of election boards. Finally, with the vote of the participated VCFs' representatives all the five subdistrict level network committees were formed. All the five committees were formed with 11 members as per By-laws of the CHT VCF Network.




**Rights Training For The CHT VCF Network Leaders**


