ED, Taungya, PC and LAO of the OLHF Project participate in the AGM along with the EDs, PCs and LAOs of rest of the 9 CSOs of the project from three hill districts. PM of BNPS and other respective staff of BNPS and Simavi Netherlands were also present in the meeting with the CSOs.

The network is working for last two years for right based approach of the adolescent girls of CHT which is a planned activity of the OLHF project focusing to fetch all the 10 CSOs of CHT under one umbrella to work for the target aged group of girls and young women. From the development stand points the 10 CSOs under technical support of BNPS and Simavi, Netherlands found committed to work on volunteer basis to address different issues of CHT adolescent girls and carry out the right based works as a social commitment and ownership of the work.

The AGM was arranged in festive mood and departing EC of the previous year (2022) happily handover the duties and responsibilities to the new elected committees with vote of thanks and gratitude. The departing chair of the committee, Ms. Sucharita Chakma, ED of Progressive Rangamati delivers her welcome speech where she focusses the major activities of NARI in 2022 and expressed her gratitude to the members for engage their proactive participation in NARI activities. She also informs the participants that the membership in NARI increased notably from the year



2021 and encourages others to be a member of NARI. Then the PM of BNPS, Mr. Sanjoy Majumder express his valuable opinion on NARI's future activities and endeavors. After that, the main part of the event took place which was the new committee formation of NARI. ED of Progressive Rangamati moderates the session with active participation of the members. The new committee was formed with Ms. Dawnai Prue Naly, ED of AKS Bandarban as the Chairperson, Mr. Chaing Seing Moung, ED of Graus Bandarban as the Secretary, Ms. Sucharita Chakma, ED of Progressive Rangamati as the Vice-Chairperson and Mr. Ramesh Chandra Tanchangya, PC of AKS Bandarban as the Treasurer for 2023.

On the 24th January to 25th January 2023, a two day long staff capacity building training on Project Advocacy was held at Parjatan Motel, Meghla, Bandarban Hill District. Mentionable that the Our Lives, Our Health, Our Future in short OLHF Project has inbuilt advocacy strategic work to implement certain objectives to achieve and make functional of the AFHS- adolescent friendly health service corners at union/upazila/ district levels GoB health service centers like- Upazila Health Complex/ Union Family & Health Welfare Center/ Family Planning/ Sadar Hospitals. Under the OLHF Project Taungya is working in three upazila (Bagheisori, Borkol and Bileisori upazila) and targets to make functional of 6 corners in Bagheisori, 6 in Borkol and 4 in Bileisori upazila.

The training was inaugurated by Sanjoy Majumder, PM, BNPS and facilitated by Ishaque Faruqe, Advocacy Officer, BNPS. The two day long training focused to strengthen basic advocacy knowledge of the recruited officers, share project advocacy strategy and on the last day development of the project advocacy plan. The participants shares their previous work experiences with the government and other stakeholders, CHT context and realistic advocacy challenges. Later in a participatory way, a broad discussion regarding proper communication, rapport building and main-

taining linkages with the Govt. and other stakeholders took place during the training. OLHF Project Coordinator of Taungya express opinion in this regard- "I assume the training has enriched technical knowledge of the LAO and the sharing and discussion of the advocacy strategy of the project as well as the plan will contribute to better understanding of the officers though we know the challenges and some constrain need to be addressed in much tactical manner."

On the final day honorable chairman of BHDC Mr. Kyaw Shwe Hla joined as chief guest in the closing session and Master Trainer, Sumit Banik from BNPS presents a power point presentation on project activities, achievements and current status of the project. During the welcome speech Executive Director of GRAUS requests the honorable chairman for infrastructure and water supply support for establishing MHMfriendly toilets in schools. Singmau Marma a girl from Talukder Para Girls' Club, Bandarban also delivers a speech and also shares her experiences and learning from the club activities. Later she ends her speech and requests for a sewing machine for making reusable MHM materials for their club members besides another request to provide support for Karate training for self-defense for the club members. Mr. Chairman, in his speeches, expresses gratitude to the CSOs that working for the adolescent girls in CHT and says- "It is not easy to work in CHT remote corners and the native girls must be aware of their customs and practices for learning their rights and activities. We all have different customs, traditions and beliefs. So, we will understand the women rights aligning with these as the society is not yet ready for many issues from global context".

Departing EC members hand over their duties in formal manners and by welcoming the new EC members with flower bucket along with the small funds contributed by the members since last two years to use in need of NARI works.

The newly elected chairperson Ms. Dawnai Prue Naly expresses her humble gratitude to the participants and the previous executive committee members for choosing them. She along with the new EC members express bright hope to work for the betterment of NARI in the future on basis of its vision and mission.

CASE STUDY

Girls' Club Awareness Session Started to Positively Contribute to Prevent Early Marriage Among the Indigenous People in Hard to **Reach Areas of Borkol**

18 years old Minati Chakma (pseudonym) lives with her husband, my father and mother in laws in Mora Thega village. Her husband is a farmer and daily wage labour. She was forcefully married in 2019 when she was only 15 years old. Besides the income of her husband she tries to provide support by helping her mother-in-law to make their traditional cake/pitha and selling them to local market.

Minati is the third child of four children of her parents. Her father is a fisherman and mother is a house wife. Though her father is a poor fisherman but he tries hard to provide support to education of his children. The village of Minati Chakma is located in a remote corner of the upazila and disadvanced in all aspects like- education, primary health service and availability of sanitation, communication etc. There are 60-70 households live in the village and when anyone get sick they go to the village quack though the villagers do not get good result from the treatment. As she belongs to a financially poor family it was always difficult for them to get better treatment from the Upazila Health Complex or live and study there. So, they did not have good idea about women's rights, gender based violence, menstrual health management. Now she understand for this unawareness she was forced to married early and before she was ready for it.

After completing her primary education from the primary school of their neighboring village in 2016 she was admitted to the high school about 8-10 km. distance from their village. She was not bad at her study and her family had good hope on me. So she starts living as pay guest type system in a respected villager adjacent to the school. In 2018, when she was studying in class eight, she became acquainted with a boy from their neighboring village and after sometime it turns into love affairs. They used to meet secretly. He was in class nine at that time. Within a yearlong secret relationship there were no physical relation between them and they only meet for chatting and spend some time together. One day afternoon in 2019 when her annual exam was completed and they both decide to meet to the backside of the school. At that time few youths discover them alone backside of the school and accused them for doing sex and force them to village elders for judgement. After two days of that incident the village elders summon their parents and start village court against them. The elders find them guilty and verdict to married each other or parents of her boyfriend must compensate one lac taka to her parents which was not possible as they were also very poor and they disagree to compensate and demand to let them married. The elders, considering their tender age decide it to be arranged when we will be physically matured. But whether one month passes or not her would be mother-in-law creates pressure on her family for marriage. Her parents become motivated and arrange their marriage without thinking. An elder brother of the village requests both of their parents not to do it and tries to make them understand that it will create many problems if they get married such tender age. But both their parents ignores it. They both were not ready for this marriage. At this time, impact of worldwide COVID-19 also reaches their locality and their study becomes completely closed for it as the school was declared closed for uncertain period.

She had no idea of running a family and her mother-in-law themed to mean on me for it. She becomes pregnant in the year end of their marriage and within three months she faces miscarriage and mental torture of her mother-in-law increases. She could not say nothing as she was scared.

One day in 2023, she came to know about the opening of a girl's' club under OLHF project by local NGO Taungya. A didi comes to their village and informs them about it works and she becomes interested and get herself admitted as a member of Thega Mukh Marma Para Girl's Club. During the first few days she was irregular but she becomes interested, attentive and regular when session on MHM, SRHR, girls' rights and early marriage start. But for spending time in the club her mother-in-law themed to mean to me. Carefully she tries to discuss with her about the knowledge she learned on negative impact of early marriage and immature condition of the girls reproductive organs and body but she does not become slight interested rather ignored it consciously. One day the elder brother that tried to stop her early marriage visit their village and she share her story after marriage to him. He becomes sad to hear it. But he tries not to discuss about the matter with her mother-in-law rather one day takes her to a session in the club. That day their club Mentor discusses on information on sexual and reproductive health & rights, gender based violence and especially on negative impact of early marriage. She presents and moderate the sessions with the mother groups nicely as usual. After that day miraculously and silently she starts to change and began to lessen her mental torture on her gradually. Latter she starts making her as beloved one and sometime expresses her regrets for her rough attitude she did to Minati. Consequently her torture totally stops in short time.

At present there is no such problem in their family. Her mother-in-law guides her in their household jobs and she also heartily assist her. On the other hand she shared her knowledge with her husband that she has been learning from their girls' club so they decide to take baby when they both will be physically matured and ready for a new comer in the family. Her husband also agrees with her in this decision. "Like all other Girls' Club members of the project that had very little knowledge on menstrual health management, sexual and reproductive health and gender base violence, concept of friend selection, women's rights, I can say that the project did not provide us money or other facilities for livelihood development but what the project has provided us is priceless and it was the just thing that we adolescent girls' needed the most" said Minati Chakma.

"It was the second official visit from govt. department in the project of Bagheisori Upazila and UNO expressed satisfaction of the project thematic works and mass level sensitization on SRHR, MHM and GBV of the OLHF Project" said Project Coordinator, Kuldip Roy.
